Falling branches from trees.	All users	Annual dead wood clearing of trees. Leader to carry out visual checks of trees. Regular tree checks are carried out.	3	5	15	
Injury resulting from environmental or weather conditions.	All users	If thunder or lightning is seen or heard, the activity must stop immediately. The activity can resume 20 minutes after the last thunder is heard. Leader's ongoing risk assessment and judgement will decide whether to continue or put a stop to the activity.
